**Special Tariff**

The **Agricultural Tariff – Reduced Agricultural Tariff** is a variable rate product, exclusively designed for agricultural holdings engaged in or contributing to, in any way whatsoever, the production of primary crop and livestock products, in accordance with those provided for in the JMD 142196/10-11-87 on "**Measures for Rural Electrification**"

**Supply Charges**

**A. Fixed Charge – Basic Supply Price**

**B. Fluctuation Mechanism February 2025**

- When the variable TEA<sub>m-1</sub> is greater than the upper limit L<sub>u</sub>, then the calculation formula  $\alpha * (TEA_{m-1} - L_u) + \beta$  shall be used
- When the variable TEA<sub>m-1</sub> is less than the lower limit L<sub>d</sub>, then the calculation formula  $\alpha * (TEA_{m-1} - L_d) + \beta$  shall be used
- Zero charge when the variable TEA<sub>m-1</sub> is within the range L<sub>d</sub> and L<sub>u</sub>

Where,

- $\beta = \alpha * (TEA_{m-1} - TEA_{m-2})$
- TEA<sub>m-1</sub> shall mean the mean daily Day-Ahead Market Clearing Prices of the month preceding the consumption month "M", as published by the Energy Exchange, in €/kWh
- TEA<sub>m-2</sub> shall mean the mean daily Day-Ahead Market Settlement Prices of the month preceding by two calendar months the consumption month "M", as published by the Energy Exchange, in €/kWh

**C. Final Supply Price February 2025**

The Final Supply Price results from the sum of the Final Basic Supply Price and the Fluctuation Mechanism

<b>Fixed fee (€/month)</b>	<b>5.0</b>
<b>Final Supply Price (€/kWh)</b>	<b>0.14970</b>

## Clarifications

- The **Agricultural Tariff** is granted upon application by the interested party to the Administration of Agricultural Economy and Veterinary Medicine of the competent Regional Unit, which is competent for the collection and control of the necessary supporting documents for the electrification of agricultural holdings. If at any time the initial agricultural activity is modified, the Agricultural Tariff shall no longer be applied
- Under the **Agricultural Tariff**, the charge for the energy consumed (€ per kWh) remains fixed irrespective of the level of consumption
- The amount of the fixed fee is always calculated pro rata by applying a day reduction coefficient (number of billing days/30)
- Discounts may apply on fixed fees and basic supply charges, as posted on [www.dei.gr](http://www.dei.gr)

## Regulated Charges<sup>1</sup>

The Regulated Charges are approved by the State and apply to all customers using the National Electricity System, irrespective of the supplier they have chosen
